A complete set of bidding document in English may be purchased by interested eligible bidders upon the submission of a written application to the address below, in PDF and Word format and upon payment of a nonrefundable fee of LAK 1,000,000.00 (One Million Lao Kip). The method of payment will be in cash. If there are any discrepancies in text, the text in the PDF format will prevail. The document will be picked up from the address below or sent via e-mail.
6. Bids must be delivered to the address below on or before **14:00 o'clock of 27 October 2023**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **14:15 o'clock of 27 October 2023**.
7. All Bids must be accompanied by a Bid-Securing Declaration as per form provided in the bidding document.
